Electric Vehicle Charging

- 24 stations open for personal use
- Most stations are located in public parking facilities
- Fuel excise tax activated this year
 - Will begin charging to match the City of Iowa City
 - o https://www.icgov.org/Home/Components/News/News/744/390
 - o \$0.16 per kilowatt-hour
- Reimbursement of costs that we are being charged
- Change will start on January 1
- Communications will be coming out soon
- Are the stations we have used often?
 - o Utilization rate is relatively low so far
- Request from UIHC to add stations in the hospital ramps
 - O What would it take to make that happen?

RideShare

- UI has launched service through the previous vendor used by IDOT
- · Previous arrangement was ended over the summer
- Website has those details
